Minutes of the Annual Parish Meeting held on Tuesday, 10th April, 2018 in St. Bartholomew's Church, Finningham, starting at 7.00pm.

Chairman: Mr. A. Kilbee.

In attendance: Mr. A. Kilbee (Chairman), Miss N. Hill (Parish Clerk), 4 members of the Parish Council (Mrs. M. Webb, Mrs. C. Winter, Mr. J. Miller & Mrs. D. Sewell) and 3 members of the public.

1. Welcome & introduction by the Chairman

Apologies from Mr. J. Black & Mr. R. Negus for being unable to attend the meeting. The Chairman welcomed and thanked everyone for attending. He reminded the members of the public this meeting is their opportunity to give feedback on the activities within the Parish.

2. Minutes already approved of the Meeting held on 9th May 2017. The minutes were approved on 13th June 2017 during the Parish Council meeting.

3. Annual report from the Chairman of Finningham Parish Council.

The past year has been an active one for the Council, not least punctuated by the proposal to build a number (currently 14) in the Green Farm Yard. Such was the interest in this development that a special meeting was held, at which 43 people attended.

Thanks to the Friends of Finningham initiative, the village is looking particularly attractive this spring. The daffodils that the team of volunteers planted have made a beautiful addition to our verges and triangles. I believe that this is the start of an on-going campaign.

This floral enhancement of our village was augmented last Sunday by the Spring Litter Pick and Churchyard Clean-up. In spite of the rather damp conditions, we had a reasonable turn out of volunteers, who were able to collect a considerable amount of rubbish from the verges and other public areas. With the number of people who came, we were able to cover all the roads in the village but Walsham Road was so bad that it could not be completed.

By now, the replacement swing should have been installed but the weather has been against us; with the result that the Green was flooded. It will be scheduled to be done in another two weeks. This is the first phase of a planned expansion of our play area. An adult exercise area is also planned but both are dependent on being able to obtain grants. We are also considering an all-weather cricket pitch on the Green.

It is very unfortunate that, due to rising costs, we have had to increase the Parish Council's portion of the Council Tax burden. We have kept this to an absolute minimum and we can only do this by being a self-help Parish. Whenever we call for volunteers it is usually the "Good Old Faithfuls" who come to our aid. It would be wonderful if this band of Merry Men and Ladies could be enlarged, perhaps by canvassing for new recruits.

One of our major issues is the communication with residents. Of course, there is the Newsletter, which is a very good medium but, as it is published only every two months, information can become dated and forgotten. We also have a website (actually run by FoF) and there is a Facebook page and now many people are on the Neighbourhood system. In spite of all these, we still find it difficult to get the message across. If anyone has any ideas how we could improve matters, please let us know.
