Following on from last month's approval of the area to be improved and included within the quote for removing the swings, the surface to be laid wasn't included. Therefore, should gravel (20mm) be used, 2 bags would be needed at £47.50 a bag. Or to use Hoggin.
- 12. To discuss and approve cutting of the Green now Mr. A. Brownlie no longer wants to do it. Does the Council consider purchasing their own mower? A loan would be needed for this, as well as ensuring it can be stored as well as having offers from parishioners to cut the Green. Last year, £720 was spend cutting the Green (12 cuts). Or do the Council find another contractor to cut the Green?

To discuss and approve the next steps for an electricity supplier for the defib after the quote given by Green Energy was withdrawn due to an error on their part mis-quoting a zero standing charge rate. Quotes obtained are BES, free meter installation, 32p a day standing charge and 16.80p per unit. Npower, £100 + VAT for meter, £23.11 a month standing charge and 15.693p per unit.
