DC/19/03437 – Submission of details for reserved matters granted under Outline Planning Permission DC/18/05535 for the scale, appearance, landscaping and layout for 6No. dwellings with associated parking and vehicular access. Land South Side Of, Westhorpe Road, Finningham, Stowmarket Suffolk IP14 4TW.

Mr. Baker's comments that were emailed to the clerk requesting they be read out, were read out along with the comments submitted under this planning application on MSDC website.

It's understood from looking at the details of the planning application, surface water won't be going into the exiting water courses and French drains and soak aways will be installed at the site. Foul water seems to be a problem again and doesn't seem to be dealt with again within the application.

It was agreed for the clerk to add comments to the application that there is concern about the foul water and also the 90 mtrs sight line west of the site due the planting of a Cooper Beech (T7) which is believed will reduce visibility. The council are also concerned and would want clarification on the hedgerow along the road and who's responsibility it would be to maintain this.
