# FINNINGHAM PARISH COUNCIL

Minutes for the Parish Council meeting held on Tuesday 8<sup>th</sup> March 2022 in St. Bartholomew's Church, Finningham, starting at 7:30pm

#### 21.232 Visiting speakers

Cllr Andy Mellen's County and District reports are on file. With regards to development within the village and new housing, Green Farm is coming along and there maybe something along Gislingham Road, going out of the village heading towards Gislingham. Cllr Andy Mellen was Thanked for his work in helping water/flood issues along Westhorpe Road and Wickham Road.

#### 21.233 Contribution by Members of the Public

A member of the public said Thank You to Cllr Andy Mellen and everyone for their work to get the ditch along Wickham Road cleared by Network Rail.

- 21.235 Approve minutes of the Parish Council meeting held on 8<sup>th</sup> February 2022. Mr. J. Miller proposed, seconded by Mrs C. Winter and agreed the minutes were a correct record and the Chairman then signed the minute book.

### 21.237 Matters arising from the meeting held on 8<sup>th</sup> February 2022.

- 237.01 Gislingham PC have confirmed they are happy to go halves on the estimate £1,598.11 (up to £1,000 as they appreciate it's an estimate and not a quote) for Suffolk Highways to supply & erect 2 new posts for Finningham/Gislingham village sign along the B1113. They have asked whether they can have a separate invoice from Highways for their half of the invoice.

- 237.03 No new councillor training sessions are available yet.

#### 21.238 Chairman's Report

As Paul was unable to attend our last meeting, I should like to welcome here at his first meeting as a Councillor on Finningham Parish council. I am sure that he will be a valuable addition to our team, particularly with his experience in emergency situations.

I should also like to welcome Jane Challis to our meeting. Jane is currently The Parish Clerk for Gislingham and Mellis and has indicated that she would like to be considered for that role in this council to replace Natalie. I shall ask her to give us a short presentation under item 18 of the Agenda.

A team of volunteers has been busy clearing out the Dove from the Bridge to Eastlands. I'm not sure if we decided on this at the last meeting but I feel that we should send them a note of thanks for their work.

It has been reported to me that the situation along Moon Lane has deteriorated as a large number of caravans are now parked there. This was brought to light when the Avian Flu team (based in Westhorpe Village Hall) attempted to make an inspection and were put off by their reception. As we all know, it is very difficult to get anything done about the situation there. Even more so since Mr Cracknell assisted in the removal of some large trees from the Dove during the clear-out of the river. Perhaps we should try and involve the Planning Department again. What should the PC do re Moon Lane considering during 2005-2007 the issues with Mr. Cracknell at Moon Lane. What are their toilet facilities like? Should the environmental dept as well as the planning dept at BMSDC be contacted. It was also suggested with regards to the Avian Bird Flu aspect, Trading Standards should also be contacted.

#### 21.239 Update from the Village Footpath map working group.

No news on what is happening with the leaflet as Mr. J. Black was helping with this.

#### 21.240 To discuss flooding within the village.

There was work along Westhorpe Road where it was drained which seems to take 4 tankers. Floods haven't appeared since, but there hasn't been that much rain. It seems it wasn't just sludge down the pipes, stopping water moving way from the road, but also building materials. The workers indicated that they couldn't get all the way through the pipes to clear them. Mrs. L. Charter will email the clerk with information she gained when talking to the workers, for it to be passed onto Cllr. Andy Mellen to ensure they return to fully complete and resolve the issue.

Wickham Road flooding seems to have reduced now Network Rail have cleared the ditch. The flood ner Church Lane along the B1113 still appears.

#### To discuss the monitoring of traffic speed within the village.

Mrs. L. Charter has started the newsletter with information about the PC and suggested a short bio on all councillors and promote that the PC does. She has also taken some photo's of what the PC has done to include in this newsletter.

**To discuss and approve training on how to use the defib.** Who is to offer this and is it parish council business? Mr & Mrs. Winter are happy to volunteer to give the training. It was suggested to do it alongside a coffee morning in the village.

To discuss and approve the request to lay concrete slabs in part of the churchyard. The grass between the path and the church door gets muddy and slippery in winter. Mr. A. Strickland has been thinking of laying a series of concrete slabs as stepping stones from the path to the church door. He's been told that this is the province of the parish council. There would be no cost to the Parish Council, he is planning to use slabs with a rough surface, and the intention is that they will be flush with the surrounding grass, so that there is no difficulty for mowers Mr. J. Miller proposed, seconded by Mr N. Arther and agreed the laying of concrete slabs on the path.
